EXPORT CONTROL

Personal property purchased from the U.S. Government may or may not be authorized for export from the U.S. to a foreign country. - a) The making of a false statement and concealment of any material information regarding the use or disposition, export or re-export of the property; and
- b) Any use or disposition, export or re-export of the property that is not authorized in accordance with the provisions of this Agreement.
