## AMENDED ORDER GRANTING DEFAULT JUDGMENT

On this 27<sup>th</sup> day of June, 2025, this matter comes before the Honorable Court. Plaintiff, the Oklahoma State Bureau of Narcotics and Dangerous Drugs Control, by and through the undersigned Attorney, requests pursuant to Rule 10 of the Oklahoma District Court Rules that a default judgment be entered against Defendant Currency. The Court, having reviewed the Notice, return of service, the court file and being fully apprised, finds as follows: 1. This case was filed as a civil forfeiture action on September 4, 2024.

 Service by certified mail was affected as to Qi Lin on September 30, 2024, when a copy of the Notice of Seizure and Intended Forfeiture was sent Certified Mail Restricted Delivery to his or her last known address at 10296 N. 2310 Rd, Clinton, OK 73601 and accepted.

- The Plaintiff's Notice of Seizure and Intended Forfeiture was published on October
   2024.
- 6. An additional copy of the Notice of Seizure and Intended Forfeiture was sent via FedEx to Qi Lin at 1401 Chisholm Trail, Weatherford, OK 73096 on May 13, 2025 and returned to OBN on May 21, 2025; however, Qi Lin failed to pick up delivery of the Notice.
- 7. An additional copy of the Notice of Seizure and Intended Forfeiture was sent via certified mail to Qi Lin at 22024 E. 1090 Rd. Bessie, OK 73622 on or about September 24, 2024; however, this was returned to sender as the forward time had expired.
- 8. Potential claimant(s) including Qi Lin have failed to file an Answer or responsive pleading, nor has any motion or pleading been filed on Defendant's behalf within the statutory 45-day period pursuant to 63 O.S. § 2-506.
- 9. The above-listed property is forfeitable pursuant to 63 O.S. § 2-503(A)(6), (A)(8) and (B).

## IT IS THEREFORE ORDERED, ADJUDGED, AND DECREED that all claimant(s)

have been properly notified, but none have filed an answer and claim as to the property according to 63 O.S. §2-506. Further, the State has provided sufficient evidence to prove by a preponderance of the evidence that the property at issue is subject to forfeiture.
