The undersigned(s) agrees to comply with all safety requirements, including but not limited to OSHA, environmental compliance, as well as all applicable State, federal, local and municipal laws, rules, regulations or orders while on Postal property. The undersigned(s) or their respective companies and employees agree to use reasonable care to prove the postal property, and will reimburge the Postal Service for any

care to prevent damage to postal property, and will reimburse the Postal Service for any damage or loss incurred as a result of their activities on postal property.
