1. ELECTRICAL GENERAL REQUIREMENTS

1.1 SUPPLY AND INSTALL ALL ITEMS, ARTICLES, MATERIALS, LABOR, EQUIPMENT AND TOOLS NECESSARY TO COMPLETE ALL SYSTEMS AND EQUIPMENT AS SHOWN ON THE DRAWINGS AND AS DESCRIBED IN THIS SPECIFICATION, PROVIDING A COMPLETE AND FULLY OPERATIONAL ELECTRICAL INSTALLATION.

1.2 THE DRAWING DOES NOT SHOW ALL ARCHITECTURAL AND STRUCTURAL DETAILS. ANY INFORMATION INVOLVING ACCURATE MEASUREMENT OF THE BUILDING SHALL BE MEASURED ON THE SITE. ANY CHANGES OR ADDITIONS TO ACCOMMODATE THE SITE CONDITIONS SHALL BE MADE WITHOUT CHARGE TO THE OWNER.

1.3 THE CONTRACTOR SHALL BE RESPONSIBLE FOR THE COORDINATION BETWEEN THE MECHANICAL AND ELECTRICAL WORK.

1.4 ALL WORK SHALL BE DONE IN ACCORDANCE WITH ALL CODES AND AUTHORITIES HAVING JURISDICTION INCLUDING BUT NOT LIMITED TO THE FOLLOWING: * LATEST EDITION OF THE ONTARIO BUILDING CODE * ONTARIO ELECTRICAL SAFETY CODE

1.5 ALL WORK SHALL BE DONE IN A WORKMAN-LIKE MANNER TO THE SATISFACTION OF THE CONSULTANT. WORK NOT ACCEPTABLE TO THE CONSULTANT SHALL BE REMOVED AND REPLACED WITH SPECIFIED PRODUCTS AT NO COST TO THE OWNER.

1.6 WHERE FIRE RATED WALLS, FLOORS, ROOF OR PARTITIONS ARE PIERCED TO ACCOMMODATE CONDUITS, WIREWAYS, RACEWAYS, CABLES, ETC. PROVIDE ALL NECESSARY SEALS, FITTINGS, BARRIERS AND FIRE STOP MATERIALS AND ASSEMBLIES, TO RESTORE THE INSTALLATION TO ITS ORIGINAL OR INTENDED FIRE RATING, TO THE SATISFACTION OF THE GOVERNING AUTHORITIES HAVING JURISDICTION.

1.7 THE ELECTRICAL CONTRACTOR SHALL NOTIFY THE ENGINEER ABOUT ANY DEVIATION FROM THE ORIGINAL DESIGN.

2. WIRE

2.1 ALL WIRING SHALL BE CONCEALED (I.E.) RECESSED BEHIND FINISHED SURFACES IN ALL FINISHED

2.2 ALL WIRE AND CABLE SHALL BE SIZED AND INSTALLED IN ACCORDANCE THE CODE REQUIREMENTS. NO WIRE SMALLER THAN NO. 14 AWG SHALL BE USED. ALL CONDUCTORS SHALL BE SOLID COPPER. 2.3 BX CABLE SHALL BE USED FOR ALL BRANCH CIRCUIT WIRING.

3. LIGHTS SPECIFICATION

3.1 ALL RECESSED LIGHTING FIXTURES SHALL BE THERMALLY PROTECTED IN ACCORDANCE WITH CODE. 3.2 FIXTURE AND EQUIPMENT LOCATIONS SHOWN ON THE DRAWINGS ARE APPROXIMATE ONLY. CONTRACTOR TO VERIFY SITE CONDITION PRIOR TO INSTALLATION AND REPORT DISCREPANCIES TO ENGINEER. COORDINATE WORK WITH OTHER TRADES.

3.3 SUPPLY AND INSTALL NEW CSA APPROVED AND ULC LISTED ELECTRICAL EQUIPMENT, SYSTEMS AND ASSOCIATED WIRING AS INDICATED.


